On the day of my scheduled presentation and prior to my speaking session block, I agree to be present at a rehearsal-equipment check on-site at the conference, the specific rehearsal time to be made known to me by IDSA. So that an audio visual technician can reach me during the conference, my cell phone number is provided as _____.
- 3) **For hand-outs only:** I hereby grant to IDSA a perpetual, royalty-free and world-wide license to make copies of and distribute, either alone or in conjunction with other materials, the written materials I use as hand-outs for my presentation. These copies will be used for the presentation day only.
- 4) I agree that IDSA may use my name, likeness, portrait, picture, biographical material and appearance during the Conference to advertise and publicize any use whatsoever of the Conference.
- 5) I hereby warrant that all materials contained in the hand-outs and my presentation were created by me and are owned by me. Any materials not owned by me are the subject of valid permissions from the copyright owners. Any such permission(s) include an acknowledgement that the materials will be reproduced and distributed by me and/or IDSA. This warranty will survive the termination or expiration of this Agreement for any reason.
- 6) I further agree to indemnify and hold IDSA and its officers, directors, employees, agents, and members harmless with respect to any and all claims, losses, damages, liabilities, judgments or settlements, including reasonable attorneys' fees, costs and expenses incurred by IDSA on account of any activities, including copyright infringement, defamation or slanderous content, used or conducted by the Presenter pursuant to this Agreement.
